Industrial Gas Springs Ltd. (IGS) designs and manufactures Gas Springs, both compression and tension, and dampers.

To the best of our knowledge, all Industrial Gas Springs Limited (IGS) products currently in production are in compliance with the requirements of the Regulations and/or Directives as indicated above and do not contain any of the 209 Substances of Very High Concern (SVHC) in the Candidate List of Substances of Very High Concern for Authorisation as published on echa.europa.eu in a concentration at or above the allowable limit as listed in the Directive, Decision and/or Annexes.

IGS manufactured Gas Springs do not contain the substances listed in Annex II of Directive 2011/65/EU and Commission Delegated Directive (EU) 2015/863 (including all amendments) at concentrations exceeding the Maximum Concentration Values (MCV). Additionally, the Gas Springs manufactured by IGS are not considered to be EEE products as defined in the Directive as they are not *'dependant on electrical current or electromagnetic fields for at least one intended function'*.

IGS manufactured Gas Springs comply with the related requirements of European Union Regulation (EC) 1907/2006 (and amendments) concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) as under the structure of the REACH regulation, IGS is a manufacturer of articles and do not involve the *"intentional release of substances"*. Accordingly, there is no registration or pre-registration or authorisation requirement for the products we manufacture. IGS do not use chemicals in quantities of 1 tonne or more per year.
